PROMOTER

This redemption is run by Ambro Controls Pty Ltd of 7595 Irvine Center Drive | STE 100 Irvine California 92618 USA (**Promoter**).

The redemption is only open to eligible claimants. An “eligible claimant” is a person who:

- a. is a United States citizen or a resident;
- b. tags @ambrocontrols on either Instagram or TikTok using an Ambro product in the field or on a recent job for this redemption in accordance with these Terms and Conditions;

- d. does not in any way tamper with the redemption.

REDEMPTION & PROMOTION PERIOD

REDEMPTION OFFER
